Brown asked about oversight process for accountability.

Dunn responded that TDC Staff, County Administration and the Finance/Clerk's Office are all involved in processing budgets and payments, and the TDO has a dedicated Budget Analyst within the Finance Department. **Lori Bailey-Brown** confirmed Dunn's comments.

6. <u>FUND 110 Discretionary Event Funding Requests:</u>

a) \$925.00 Sommer Sports - Florida Xtreme Triathlon - November 10-13, 2017

Dunn presented that this event is a Cross Florida Triathlon; it will consist of three triathlons, three days in a row. The first day will start in Crystal River and they will swim, bike, run their way to Ocala; the second day they will swim, bike, run their way to Melrose; and the third day they will end up in Palm Coast. It will be a

Sunday finish therefore a Sunday night stay in area hotels and on Monday an awards ceremony and lunch at Captain's BBQ.

b) \$1,500.00 FLX Adventures - Sea to Sea, 72hr Adventure Race - February 28 - March 4, 2018

Dunn presented this event is a 72 hour adventure race starting on the west coast of Florida and WILL end up in the Hammock area of Palm Coast. Palm Coast Villas will serve as host hotel; Hammock Community Center will be used the first night to host a race organization meeting; the next day the athletes will be bussed to the West Coast of Florida; the majority of family members will stay in Palm Coast while the race is happening. This is a running, biking, paddling race and will end in Palm Coast.

c) \$3,800 Peak Living Property Management – Peak Summit and Training Retreat – April 8-13, 2018 (tentative)

Dunn presented that we are splitting the transportation costs with the Hammock Beach Resort to assist in bringing this group to Flagler County which will result in about 600 mid-week room stays.

d) \$25,000 Triton Collective/Flagler Beach Ocean Rescue - Coquina Cup - May 18-25, 2018

Dunn presented this event is intended to be a beach/ocean style festival of competition with paddle board races, lifeguard skills competitions and open water swimming races. TDC Staff are developing this event in partnership with Triton Collective. USLA (United States Lifeguard Association) officials will also assist in developing the event in conjunction with bringing the USLA competition to Flagler Beach in July of 2018. Mayor Provencher, Chief Pace, Chief Doughney, Ocean Rescue Director Gillin and City Manager Newsom have all been included in the planning process.
